What makes this property truly unique is its versatility. Multiple buildings across the land create a perfect setup for retreats, events, family compounds, or lakefront hosting. A conference building with kitchenette and projector-ready space is ideal for workshops and gatherings, while a second glass-lined building captures panoramic views beneath vaulted beams. The main house features lake views and a massive, covered porch overlooking the water. Additional guest buildings provide extra living quarters, kitchens, bathrooms, and lakeview decks. An outdoor bathhouse with multiple showers and restrooms makes cleanup easy after long lake days. Massive shoreline. Acreage. Endless possibilities.
