Discreetly nestled on 2.48 private wooded acres in Cedar Hill, this custom 4,000+ sq ft residence offers refined luxury, architectural character, and estate-style privacy. Accessed by a winding drive and framed by stone entry, the home is surrounded by mature trees and serene natural views. Inside, soaring vaulted ceilings, skylights, rich woodwork, designer built-ins, and wood-framed windows create warmth and architectural distinction. The main level is designed for both entertaining and everyday living, featuring two living areas anchored by stone fireplaces, a formal dining room, and a kitchen with breakfast area overlooking the landscaped grounds and resort-style pool, flowing seamlessly into a wet bar. The primary suite occupies its own private wing and includes a spa-inspired bath with garden tub, separate shower, double vanity, dual walk-in closets, and a distinct adjoining sitting area ideal for lounge, nursery, office, or dressing space. A dedicated home office with adjoining TV room further enhances the flexibility of the main floor. Upstairs, two additional bedrooms and full bath are complemented by a substantial secondary living area with wet bar, creating a private retreat well suited for guests, teens, or multi-generational living. Additional features include a large pantry, spacious laundry room with storage, newer roof, and three AC units. Outdoor living includes a pool, gazebo, expansive patio, and a layered landscape design that frames a defined lawn and gathering areas before transitioning naturally to wooded privacy beyond. Completing the property is a detached three-car garage, separate workshop, and lawn equipment garage. While offering the privacy of an acreage estate, the home remains conveniently positioned near Joe Pool Lake recreation, regional trail systems, major thoroughfares, and access to DFW Airport and the greater Dallas area.
