Expansive 18-foot ceilings and full-view windows fill the entry, family, and dining rooms with natural light, while the sleek white brick exterior with black window frames create a striking first impression. The flexible floor plan offers two bedrooms on the main level, ideal for guests or multi generational living, with walk-in closets in all secondary bedrooms, a tray-ceiling primary suite, sound-dampened media room, and spacious game room. Designed for entertaining, the chef's kitchen showcases custom site-finished shaker cabinetry, a furniture-style island, continuous stone slab back splash with hidden outlets, walk-in pantry, butler's pantry with wet-bar prep, and upgraded Kitchen Aid appliances including a 6-burner gas cook top with and a power steam dishwasher. The spa like main bath features an oversized shower with tile to the ceiling, frameless glass and matte black fixtures. An oversized soaking tub is located upstairs. Elevated finishes include wide-plank engineered hardwoods, upgraded carpet with memory foam padding, Rockport-style interior doors, a barn door connecting the primary suite to the bath, and a generously sized primary closet with direct utility room access. The pool-sized backyard offers gas for outdoor entertaining, while the rare 40-foot long double-bay 4-car garage plus dedicated storage area provides exceptional space for vehicles, toys or a workshop. Over \$10,000 in electrical and tech upgrades complete this exceptional home, including under-cabinet lighting, exterior uplighting, additional recessed lighting, upgraded fan controls, and seamless quartz back splashes with concealed outlets.
