The home includes approximately 3,485 square feet with 4 bedrooms and 3.5 baths, multiple living areas, and flexible spaces for daily living and entertaining. Above the garage is an additional 950 sqft bonus room. The remodeled chef's kitchen features custom cabinetry, granite countertops, Monogram gas range and microwave, dual trash drawer, and tile backsplash. The living area includes a custom faux stone fireplace with bespoke mantle and a ventless gas log system. Updates include solar tubes, updated lighting, fresh paint, and new flooring. The primary suite includes an updated bath with rock walk in shower with three shower heads, granite counters, updated cabinetry and sinks, a freestanding tub set on rock flooring, and a ceiling fan. Guest baths feature tile walk-in showers, granite counters, copper sinks, and updated fixtures. The bonus room has a sink and counter space, a bathroom, sealed wood stairs, and offers flexible use as a private guest or mother-in-law suite. Outdoor features include a covered wood deck, flagstone walkways, a bridge over a seasonal creek, native East Texas landscaping, fruit trees, and berry plantings. A stocked almost 3-acre fishing pond with lighted dock and windmill aeration anchors the setting. Established Purple Martins provide natural insect control. Additional improvements include a 24x40 metal shop on slab, 1200 sqft walkout basement with workshop, new roof and gutters, new window screens, replaced ceiling fans, three new water heaters, sunroom roll up shades, security gate and alarm system, and an approximately 490 foot water well.
