Step outside to over 1,200 square feet of covered outdoor living, featuring a full kitchen area and a wood-burning fireplace, perfectly positioned to take in wide-open sunset views across neighboring acreage. Built for efficiency and durability, the home includes spray foam insulation, dual HVAC systems, instant gas water heaters, and a standing seam metal roof designed to withstand Texas weather. The property truly stands apart with a 50x40 shop, 40x20 lean-to, and 40x25 covered carport, along with RV hookup and dual 200-amp electrical panels—ideal for a business, equipment storage, or hobby use. Additional improvements include a storage building, chicken coop with electricity, cross fencing, sprinkler system, 320-ft well, water run to the back of the property, and infrastructure in place for future expansion.
