The family room with a floor-to-ceiling stone fireplace connects seamlessly to the Deluxe Kitchen, which is equipped with built-in-stainless appliances, gas cooking, double ovens, granite countertops, a large island, walk-in pantry, pot-and-pan drawers, and upper cabinets to the ceiling. The primary suite is privately located on the first floor and includes a cozy seating area, walk-in closet and an upgraded bath with tile to ceiling shower and tub.
