The foyer is anchored by a statement chandelier and a pair of wood-framed glass doors, with an arched opening that draws you into the main living spaces. The main living area offers a comfortable, open layout with a stately fireplace and multiple sets of glass doors that bring in natural light and connect to the outdoors. A secondary living or sitting area provides additional flexibility, while the dining space is set just off the main room for easy flow. The kitchen features abundant storage in light cabinetry and bar seating with tasteful pendant lighting overhead. Stainless steel appliances, including a double oven, complement the clean design, while a tiled backsplash and ample counter space enhance functionality. The primary bedroom showcases wood flooring, a distinctive wood-beam ceiling, and room for a sitting area. The en suite bath includes a freestanding tub, a separate tiled shower, and a dual-sink vanity, along with a generously sized closet outfitted with built-in organization.
