DESCRIPTION

Newer construction with a heated saltwater pool, a pool deck with multiple seating and dining areas, and a covered 20x18 pavilion with outdoor kitchen, on an oversized pie-shaped lot backing to a walking trail with no direct rear neighbors. The home offers 4 bedrooms, 4.5 baths, plus a study, game room, and separate media room. The resort-style outdoor space features a pool with waterfall, tanning ledge, and LED lighting for evening use. The covered pavilion adds functional space with a gas grill, beverage center, outdoor TV wall, gas fireplace, and a separate gas firepit—making it easy to host or unwind without going back inside. Inside, the kitchen opens to the family and breakfast areas and is designed for both everyday use and hosting. It features double-stacked, ceiling-height cabinetry for added storage, quartz countertops, and a large island with recycling center, beverage fridge, and wine chiller. Appliances consist of a 6-burner gas cooktop, microwave drawer, and double ovens. Additional details include lower cabinet pullouts and under-cabinet lighting. Flexible floor plan with each bedroom having its own bath. The primary suite and a secondary bedroom are on the main level, with the secondary bedroom split for privacy and offering its own bath, while a separate powder bath serves guests. A private study is also located on the main level. Upstairs includes a game room and separate media room, along with two additional bedrooms, each with its own bath. Additional features include prewiring for speakers (media room and outdoor pavilion), exterior camera wiring, smart home controls for lighting, climate, and security, Tesla charger wiring, an epoxy-coated garage floor for easy maintenance, high ceilings, and 8-foot doors that enhance the sense of space. Located in Harvest within Argyle ISD. Community amenities include pools, trails, parks, playgrounds, and community events that keep residents active and connected.
