The 2,376 square feet includes an approximately 400 square foot enclosed garden room with dedicated HVAC units and views of the backyard, offering flexibility for a variety of uses depending on your needs. The clay tile roof has been recently repaired and sealed, and the HVAC system is approximately four years old. A plumbing service line warranty is available, with the seller covering the first year if the buyer chooses to purchase it.
